No rebate will be issued to customers whose account(s) are in arrears or inactive or whose consumption does not generate a rebate amount above \$5. Econnergy reserves the right to discontinue this offer at any time. Rebate offer is valid on variable rate products only. Usage and credit minimums may apply. I agree to purchase all of the natural gas necessary to satisfy my requirements for such account(s), at the price specified herein. The initial term ("Initial Term") of my agreement with Econnergy shall commence on the date that the change of provider to Econnergy is deemed effective by my local utility company and it shall continue for 12 months. The price I will pay for all natural gas supplied by Econnergy during the Initial Term shall be a variable rate set by Econnergy based on market conditions and will fluctuate monthly. This Agreement will automatically renew at Econnergy's variable rate as per Econnergy's New York Residential Terms and Conditions v.011007.R.a ("Terms and Conditions"). There is no cancellation fee on the variable rate service plan if proper notice is provided, as per Econnergy's Terms and Conditions.

I hereby authorize Econnergy to obtain information about me from credit-reporting agencies and my local utility company including, without limitation; credit history, consumption history and billing determinants. I understand that Econnergy may use such information to determine whether to commence and/or continue to provide energy supply service to me and to facilitate collection of monies owed.
