WAIVE PARKING-WASHINGTON STREET RES.#300-18 It was moved by Trustee Becker, seconded by Trustee Reardon, to waive parking restrictions on Washington Street from October 15th – November 7, 2018 for the employees of Verizon to accommodate the temporary closing of their on-site parking lot. Motion carried, all voting "Aye."

SET BID DATE-1/20/19-2019 SIDEWALK REPAIRS RES.#301-18

It was moved by Trustee Reardon, seconded by Trustee Becker, to set the date of January 20, 2019 at 11:00 A.M. to receive bids for 2019 Sidewalk Repairs. Motion carried, all voting "Aye."

BID AWARD – HVAC MAINTENANCE-VILLAGE HALL RES.#302-18 Village Administrator John Giordano advised that twelve (12) bids packages were sent out to contractors and two (2) were received on October 11, 2018 for HVAC Maintenance at Village Hall as follows:

BID AWARD – RFP-LPR/CAMERA DESIGN RES.#304-18 Village Administrator John Giordano advised that the RFP for LPR/Camera Design was rebid after proposals were received from Alliance Systems, Greenman-Pedersen, Inc. and Cameron Engineering on August 30, 2018 and two (2) bids were received on October 4, 2018.
