CHAMBER OF COMMERCE BANNER

AWARD-LYNBROOK TITANS WRESTLING

HOLOCAUST REMEMBRANCE Mayor Hendrick proclaimed the week of Sunday, April 12 through Sunday, April 19, 2015, as Day of Remembrance in memory of the victims of the Holocaust.

PUBLIC HEARING-ARTS & CULTURAL OVERLAY DISTRICT

RES.#119-15

It was moved by Trustee Hawxhurst, seconded by Trustee Atkinson to open a Public Hearing to consider the enactment of Local Law #6 of 2015 to amend the Village Code to adopt a new Article VIIA to Chapter 252 - Zoning entitled "Arts and Cultural Overlay District"; in the "Commercial" zoning district. Motion carried, all voting "Aye." Special Attorney Jack Libert read the proposed Local Law and discussed its intent, and introduced Village Consultant Marwa Fawaz of VHB Planners, who summarized the benefits of the proposed law and indicated that it would not result on any adverse impact to the environment. Patrick Lenahan of VHB commented on how the Law would benefit the business district, by encouraging Museums, Theatres and Cultural Arts uses to the central business district as defined for the purpose of the Law to be bounded by Peninsula Boulevard and Sunrise Highway, from Earle Avenue to Neiman Avenue. The Mayor asked for comments. Jeff Greenfield, Chairman of the Nassau County Planning Commission, indicated the Commission had no objection to the proposed Local Law. After a lengthy conversation and no further comments, it was moved by Trustee Beach, seconded by Trustee Hawxhurst, to close the Public Hearing and render a decision following tonight's Public Hearing to consider an application for inclusion into this Overlay District by Lynbrook Theatre Group. Motion carried, all voting "Aye."

P.H.-SITE PLAN REVIEW-REGAL THEATRES-321 MERRICK ROAD

RES.#120-15

It was moved by Trustee Beach, seconded by Trustee Becker, to also open a Public Hearing to consider an application from Lynbrook Theatre Group, LLC, for Site Plan Review for the demolition and construction of a new Movie Theatre at 321 Merrick Road, and to consider the inclusion of the site into the newly formed "Arts and Cultural Overlay District" pursuant to Village Code Article VIIA. Mrs. Miriam Milgram, Esq. of Berkman, Henoch, Peterson, Peddy and Fenchel, PC., representing the applicant, introduced Mr. David Blumenthal, of Blumenthal Development Group Contractors, who indicated that the application provides for the construction of a new movie theatre having 1,660 seats to replace the existing theatre, which is to be demolished, having 1,605 seats on their parcel known as Section 61, Block 3, Lot 13, 321 Merrick Road, owned by Regal Entertainment. Mr. Blumenthal introduced Mr. Gerry Grewe of Regal Entertainment who added that the theatre would have large electric reclining seats and 13 screens. Chris Robinson of RMS Engineering, Consultants for the Applicant, presented the site plan showing the proposed building which would have 81,486 square feet, with entrance on the east side, and provisions for landscaping and storm water disposal. Mr. Grewe indicated that each of the 13 auditoriums would have a range of 75-125 seats. Wayne Mullof of RMS Engineering presented a Parking and Traffic study which included a review of 1,075 on and off street parking available to accommodate the additional 55 seats, increased potential theatre attendance, and displaced onsite parking. Mr. Mullof added that there would be no impact to traffic resulting from the additional patronage of the theatre. The Mayor asked if anyone would like to comment. Jeff Greenfield, as Vice President of the Lynbrook Chamber of Commerce, indicated that the Chamber supports the Site-Plan Application. William Gaylor II, Vice President of the Chamber of Commerce and President of Lynbrook Gardens Co-op and proprietor of Lyn Gift Shop on Atlantic Avenue, indicated that his organizations are in favor of the application. Patrick Cox – 17-19 Langdon Place, commented on parking, height and attendance. Mr. Robinson indicated that some parts of the building would be 77' high, including a 5' parapet. Mark DeRossa, owner of 337-343 Merrick Road, commented that the west side yard setback and height may diminish sunlight and fresh air for his building. After no further comments, it was moved by Trustee Beach, seconded by Trustee Becker, to close the Public Hearing. Motion carried, all voting "Aye." It was moved by Trustee Beach, seconded by Trustee Atkinson, that the Board of Trustees, as Lead Agency, issue a Negative Declaration for this action as it has no significant adverse impact on the environment pursuant to the New York State Environmental Quality Review Act. Motion carried, all voting "Aye."

RES.#-<u>121-15</u>

It was moved by Trustee Becker, seconded by Trustee Atkinson, to enact proposed Local Law #6 of 2015. Motion carried, all voting "Aye."

RES>#122-15

It was moved by Trustee Beach, seconded by Trustee Becker, to grant the petition from Lynbrook Theatre Group for inclusion of 321 Merrick Road, Section 61, Bock 3, Lot 13, in the new Arts and Cultural Overlay District pursuant to Article VIIA of the Village Code upon effective date of Local Law #6 of 2015. Motion carried, all voting "Aye."
