PUBLIC HEARING -14 DEVINE STREET - SUB-DIVISION

RES.#223-19

The Mayor opened a Public Hearing to consider an application from Summit Homes USA, as contract vendee, to the Village Board acting as Planning Board for a minor subdivision of the property known as 14 Devine Street as shown on the Nassau County Land and Tax Map Section 38, Block P, Lots 16-109 into two separate lots. Christian Ward, Esq. representing the applicant advised that the existing 80'x100' lot would be split into 2-40'x100' lots, which would be buildable if the Village Board of Zoning Appeals grants a frontage and lot area variance to accommodate the subdivision, and that the construction of 2 one family homes at the site would have the same density as 1 two family home, which is permitted as a right. Barry Nelson, Real Estate Appraiser, representing the applicant presented photos of the home and property in blighted condition, sales data of comparable homes, and radius map showing other non-conforming lot parcels; each of the two proposed new homes would have interior garages and onsite parking for 1 car. Mr. Nelson added that the additional home built at the site would not impact traffic. Bruce Haffner, Esq. representing Mr. & Mrs. Vislocky, owners of the property, advised that they do not have the financial ability to repair the existing home, nor satisfy the tax liens. The Mayor asked if anybody wished to comment. individuals commented: Lucille Postiglione – 15 Devine Street, Kevin Filipski – 21 Devine Street, Edwin Araque – 35 Arthur Ave., Umberto Postiglione – 15 Devine Street, Howard Volin – 30 Devine Street.

Steve Maroney - 9 Leaman Place, Contract Vendee indicated that construction would take approximately 6 months. After no further comments, it was moved by Trustee Boccio, seconded by Trustee Reardon, to close the Hearing and reserve decision until the Nassau County Planning Commission renders a 239-M decision on the application. Motion carried, Trustee Becker absent, all others voting "Aye."

PUBLIC HEARING – CHAP.222-TAXATION – SENIOR CITIZEN EXEMPTION RES.#224-19 It was moved by Mayor Beach to table a Public Hearing to consider the enactment of proposed Local Law #5 of 2019 to amend Village Code, Chapter 222, Section 222-17 entitled "Taxation" to modify the income limits for eligibility for Senior Citizen Tax Exemption as provided by Section 457 of the Real Property Tax Law, to the August 19, 2019 meeting.
