AMEND VEHICLE & TRAFFIC CODE-PARKING-HEMPSTEAD AVENUE

PUBLIC HEARING-CHAP. 6 – ARCHITECTURAL

REVIEW BOARD

– 124 EARLE
AVENUE – SUBDIVISION

It was moved by Trustee Hendrick, seconded by Trustee Beach to open a Public Hearing to consider an application from CRG Building for a 3 lot subdivision at 124 Earle Avenue pursuant to Chapter 7 of the Village Code. Mr. Vincent Muscarella, Esq., representing the applicant discussed the application and advised that each new lot would comply with all area and use requirements, except a variance would be applied for lot area for 500 square feet per parcel, and 5 feet of frontage as each lot has 50 feet of frontage, while the code requires 55 feet. Mr. Barry Nelson, Appraiser, advised that 3 one family homes would be compatible with the neighborhood, and the Code would allow as a right the construction of 2-2 family dwellings. Mr. Nelson added that all landscaping would be restored, and the existing 2 ½ story residence would be demolished. Building Superintendent Stanton indicated that the proposal is consistent with many parcels in the community. The Mayor asked if anyone would like to comment. After no further comment, it was moved by Trustee Hendrick, seconded by Trustee Beach to close the hearing and reserve decision. Motion carried, Mayor Curran abstained, all others voting "Aye".
