MARRIOTT HOTEL EXTENSION-LEASE DEVELOPMENT AGREEMENT

RES.#168-17

Bruce Haffner, Esq., representing Browning Hotel Properties advised that there are expired provisions in the Lease Development Agreement (LDA), which provides for the construction of a Marriott Hotel in Municipal Parking Field #3 on Langdon Place/Broadway executed in January of 2015, and requested that the Board grant an extension of such expired terms. Special Village Counsel Ben Truncal advised that if the extension is granted, hearings will then be held to consider inclusion of the proposed Hotel in the Cultural Arts District, and approving its Use. Mr. Haffner also requested that the Agreement be modified to allow Browning Hotel Properties to have the right to assign the LDA to another Marriott approved entity prior to completion of construction, and projected that the construction completion date would be November 2020. After a lengthy discussion, the Mayor asked if anyone would like to comment. The following individuals commented:
