P.H.-PROPOSED LOCAL LAW –CULTURAL ARTS DISTRICT AMENDMENTS

RES.#<u>268-16</u>

The Mayor opened a Public Hearing to consider the enactment of a proposed Local Law #8 of 2016 to amend the Code of the Village of Lynbrook, Chapter 252, entitled Zoning, Article VIIA Cultural Overlay District 252-46, to include the use of Hotel as an included intent and purpose. Special Counsel Benjamin Truncale summarized the proposed law and SEQRA requirements. The Mayor asked if anyone would like to comment. An unnamed resident commented.

It was moved by Trustee Beach, seconded by Trustee Reardon, to adopt the following Resolution:

Whereas, the Incorporated Village of Lynbrook (hereafter "Village") Board of Trustees has introduced proposed local law amendments to the Lynbrook Code to clearly define the minimum lot area requirements, the specific district boundaries, establish maximum height restrictions and enumerate potentials uses with the Village's Art and Cultural Overlay District (hereinafter, the "Proposed Action"); and

Whereas, SEQRA 617.6 intends that the earliest planning stages of a proposed Action, an agency shall coordinate with other involved agencies to determine the most appropriate lead agency for review of a Proposed Action; and

Whereas, the Board of Trustees has caused to be prepared a Part 1 Environmental Assessment For (EAF) as a screening tool to identify the nature of the Proposed Action, its preliminary classification, site conditions and potential impacts for the purpose of coordinated review under SEQRA; and

Whereas, the Board of Trustees intends to commence a coordinated review of Proposed Action by circulating a letter of coordinated review with the other agencies involved in approval of the Proposed Action;

Now be it hereby resolved, that the Board of Trustees hereby issues a preliminary classification of the Proposed Action as Type I; and

Be it further resolved, that the Board of Trustees authorizes the Village Clerk to issue letters to involved agencies requesting input on the Proposed Action, potential impacts, SEQRA classification and designation of lead agency, identifying the Board of Trustees' intent to act as to act as lead agency if there is no objection from involved agencies.

Motion carried, all voting "Aye."

After no further comments, it was moved by Trustee Beach, seconded by Trustee Hawxhurst to continue the Public Hearing on October 17, 2016 at 8:00 P.M. Motion carried, Trustee Becker recused himself, all others voting "Aye."
