FARMERS MARKET

RES.#277-12

BOND RES.-SEPARATION PAYMENTS

RES.#284-12

It was moved by Trustee Becker, seconded by Trustee Atkinson to approve a Bond Resolution in the amount of \$2,900,000 Serial Bonds for Separation Payments (see Exhibit A) as approved by Section 11a-106 of the Local Finance Law, authorize the engagement of Hawkins Delafield and Wood, and Liberty Capital to undertake all necessary Bond closing tasks and reimburse the General Fund in the amount of \$1,077,073 from all separation payments from April 1, 2011 to date. TAXI LICENSE MODIFICATION-VILLAGE CAR SERVICE
