Mr. David Leno, Esq., representing the applicant advised that the existing lot is zoned "Commercial" to the north, and "Residential C" to the south, and the change of zone would allow the applicant to redevelop the premises for medical offices, as the inconsistent zoning district did not affect the prior use as an office for the Long Island Water Corp. Guy Lieber, Simon Dvelopment and Brian Newman AIA, representing the applicant presented a site plan for the project showing the zoning boundry line, parking for 120 vehicles, proposed landscaping, and extension on the west side of the building. Rebecca Goldberg of Cameron Engineering also representing the applicant, submitted a Traffic Impact Study and discussed impacts to traffic volume. Mr. Leno advised that granting the zoning change would only maintain the existing use, and that there would not be any change or impact to the adjacent properties. Mayor Hendrick asked if anyone wished to speak.
