BID AWARD – LIBRARY HVAC RES.#344-16 Village Administrator John Giordano advised that bids for the emergency replacement of 1 of the 2 Library HVAC Units were received on December 8, 2016, and that out of the twenty-six (26) potential bidders, the following ten (10) bids were received:
