TRAFFIC CONTROL – DAVISON AVE.

It was moved by Trustee Beach, seconded by Trustee Becker to amend Village Vehicle & Traffic Code, Section 240-20, Schedule XIII by enacting "No Standing" School Days" to be posted on the north side of Davison Ave. from the Corner of Davison Ave. & Grace Avenue, exclusive of any no stopping here to corner regulation, east to the handicapped space in front of the school, subject to the School District installing brick between the curb and sidewalk if determined at a later date by the Village. Motion carried, all voting "Aye".

PUBLIC HEARING-CHAP.20 FIRE PREVENTION

It was moved by Trustee Beach, seconded by Trustee Hawxhurst to open a continued Public Hearing to consider the amendment of Village Code Chapter 20, Fire Prevention Bureau, to update the entire Chapter and to establish exclusive jurisdiction for the performance of certain fire prevention inspections. Mayor Hendrick asked if anyone wished to speak. After a lengthy discussion, it was moved by Trustee Becker to consult with the Lynbrook Chamber of Commerce prior to enactment of code amendment. No second, motion did not carry. After no further comments, and no motion to enact this local law, it was moved by Mayor Hendrick, seconded by Trustee Hawxhurst to close the hearing. Motion carried, all voting "Aye".

FIRE INSPECTOR WORK HOURS
