RATIFY RESOLUTION-JOHNSON CONTROLS

All actions taken by the Village Board and Village employees to implement the approval for the Johnson Controls Performance Contract between September 19, 2011 and the present are hereby ratified. RESOLUTION – BUILDING FEE WAIVER

RES.#<u>153-12</u>

It was moved by Trustee Becker, seconded by Trustee Atkinson to authorize the Board of Trustees to waive Building Department fees pursuant to Section 81-19 of the Village Code as follows:

Where a building or other structure owned by a not-for-profit corporation, which structure is used for the stated purposes of such corporation, is damaged or destroyed by an Act of God or a mechanical or electrical accident, where the Board of Trustees finds that the general good and welfare of the Village and its citizens would be served, the fee for the issuance of a building permit for the reconstruction thereof may be reduced to one-third of the fee established for building construction under Chapter 81 of the Village Code. In the exceptional case where the circumstances surrounding the said damage are catastrophic or dire in nature, the Village Board may waive the said fee entirely. In such exceptional case, the said circumstances must be placed in the minutes of the meeting of the Village Board. Motion carried, all voting "Aye".

Mayor Hendrick invited all those present for a continuation of the meeting in the conference room.
