P.H.-SPECIAL USE PERMIT -444 MERRICK ROAD-ANTENNA

It was moved by Trustee Hendrick, seconded by Trustee Beach to open a Public Hearing to consider an application from Clear Wireless, LLC to install a rooftop communication antenna on 444 Merrick Road, pursuant to Section 252-116 of the Village Code. Mr. Joseph Buzzell, Esq. presented the application and introduced his expert witnesses:

Mr. Collins indicated that the proposed antenna, collectively with all existing antennas on site emits .1088% of the maximum radio wave limits established by the Federal Communications Commission. Mr. Smith, Esq. commented on the 1997 Telecommunication Act, and advised that 444 Merrick Road was the only available site in the Lynbrook and surrounding area due to the availability of fiber optics. Mr. Smith introduced Jamie Watrel, Planner who testified that the proposed location for the antenna is suitable and has no adverse impact on the environment and community. John Steven, Infinigy Engineer reported that all conduits would conform to all NYS Building & Fire Codes, and the Mayor reported that there is an existing outstanding violation related to rooftop equipment. Michael Lynch of Lynch Appraisal advised that the proposed antenna equipment would not have any affect on surrounding property values. In response to the Mayor, Mr. Smith confirmed that no witness testified to justify need for the site, although the site could provide new 4G service. Larry Zaconi, Consultant for Clear Wireless advised that no other locations were considered in the Village. The Mayor asked if anyone wished to comment. The following individuals commented: Alan Rigano – 133 Lyon Place, Jane Grogan – 33 Green Avenue, Pat Cox – Langdon Place and Kim Coyne – 8 Woodlawn Place. It was moved by Trustee Hendrick, seconded by Trustee Beach to continue the hearing on July 19, 2010 and request the applicant to submit a rendering of the site with antenna installed, and certification that the conduit installation complies with all Building Codes. Motion carried, Mayor Curran abstained, all others voting "Aye".
