Public Hearing at 8:25 P.M. continued from the June 7, 2010 meeting to consider an application from Clear Wireless/Sprint for a rooftop antenna at 444 Merrick Road. Mr. Joseph Buzzell, Esq., representing Clear Wireless advised that panels would be added to screen the rooftop equipment, which the Architectural Review Board approved on July 7, 2010. In response to the Mayor, Mr. Buzzell indicated that the location is necessary to serve as a relay point to 135 existing antennas, as opposed to providing service to individual customers. Larry Zacconi of Clear Wireless advised that the system would utilize existing fiber optics to provide non-voice data, 4G communications. Mr. Collins of Clear Wireless advised that 4G radio frequencies emissions are governed by the FCC as voice communications are, and the cumulative amount emitted from the proposed and all other existing antennas from this site is about 1/10 of one percent of the FCC limits. The Mayor asked if anyone else would like to speak on the application. The following individuals commented: Jane Grogan - 33 Green Avenue, Phil DeSanto - Wood Street, and Kim Coyne - 8 Woodlawn Ave. indicated that over 100,000 4G phones have been sold in Nassau County since June. After no further comment, it was moved by Trustee Hendrick, seconded by Trustee Beach to close the hearing at 9:05 P.M.
