It was moved by Trustee Beach, seconded by Trustee Atkinson to re-open a Public Hearing closed on June 3, 2013 to consider the Discontinuance of part of a street known as Central Avenue, for a distance of 160 feet east of the easterly curb line of Hempstead Avenue pursuant to Village Law 6-614. The Mayor indicated that the subject section of the street to be discontinued is east of Hempstead Avenue (Exhibit C) to accommodate the construction of a new retail store at 230 Hempstead Avenue as requested by Infill Development LLC. Mayor Hendrick asked if anyone wished to speak. Anthony Guardino, Esq., representing Infill Development, LLC advised that the Discontinuance was requested to allow Infill to purchase the roadbed to assemble adjacent parcels at 220-222 Hempstead Avenue to construct a new Walgreens retail store and parking lot. Mr. Guardino indicated that joining the subject roadbed to the project would create safer ingress and egress. Harry Baker, Traffic Engineer representing Infill advised that the Discontinuance would benefit the area as it would also reduce traffic flow and improve traffic circulation in the area, and improve pedestrian safety on Grace Avenue in the vicinity of the Davison Avenue School. Bradley Cackovic AIA representing Infill reported that the existing structure at 230 Hempstead Avenue, a gym, would be demolished and a new building with adequate landscape buffer constructed. Al Calergy of Infill discussed hours of operation, and location of a drive thru window. Alysia Jessen , 211 Rolling Street, Malverne, Manager of Walgreens Franklin Square store advised on the products Walgreens typically sells. Mayor Hendrick asked if anyone wished to speak.
