WHEREAS, the Mayor and Board have determined that the Village of Lynbrook should take every reasonable measure to assist residents and businesses within the Village legal authority; and

WHEREAS, many residents and businesses requires contract work to repair damages caused by said storms which work would require such residents and business owners to undertake the process of application for and payment for building permits at the Village Department of Buildings in order to accomplish said work, a process that can take considerable time and expense; and

WHEREAS, the Mayor and Board has determined that it would be beneficial to health, safety and general welfare of the residents and businesses and of the Village of Lynbrook that the Village provide all aid and assistance possible in this aspect of government in the most efficient manner,

NOW, THEREFORE, BE IT RESOLVED

- (1) That for the 90 day period following the date of this Resolution, the Building Department will not charge fees for permits for such repair and restoration work to homes and businesses within the Village as made necessary by said storms; and
- (2) That the Building Department is hereby instructed to expedite to the fullest extent possible the processing and issuance of building permits as well as the completion of necessary subsequent inspections so as to facilitate such repairs and restoration work.
