M. for a Public Hearing to consider the adoption of proposed Local Law #7 of 2021, to amend Chapter 252 of the Code of the Village of Lynbrook entitled “Zoning”, to consider repealing subsection 38(5) which prohibits the brewing or distilling of beers or liquors in a Light Manufacturing zoning district and adding a new subsection 37(12) which would allow brewing or distilling of beer or liquors in a Commercial zoning district subject to Board of Trustee approval. Motion carried, all voting “Aye”. It was moved by Trustee Boccio, seconded by Trustee Ryder, that the Board of Trustees declares itself as Lead Agency and that a Negative Declaration be issued for this action as it has no significant adverse impact on the environment pursuant to the New York State Environmental Quality Review Act. Motion carried, all voting “Aye”.

Mayor Beach opened a Public Hearing at 7:16 pm to consider the enactment of Local Law #6 of 2021 to amend Chapter 113 of the Code of the Village of Lynbrook entitled, “Electronic Cigarettes and Hookahs”, to prohibit the smoking or vaping of cannabis on all village owned properties and public areas. The Mayor read the proposed Local Law and asked for comments, after no further comments, it was moved by Deputy Mayor Hawxhurst, seconded by Trustee Reardon, to close the Hearing at 7:22 pm and enact Local Law #6 of 2021. Motion carried, all voting “Aye”. It was moved by Deputy Mayor Hawxhurst, seconded by Trustee Boccio, that the Board of Trustees declares itself as Lead Agency and that a Negative Declaration be issued for this action as it has no significant adverse impact on the environment pursuant to the New York State Environmental Quality Review Act. Motion carried, all voting “Aye”.
